

Dear homeowners',

Please allow me to introduce myself; I'm your neighbor and the community representative on the Travis Ranch Board of Directors. The advisory committee has proposed the addition of a dog park to our community and since the park's placement would be in the vicinity of your home, we are sending this letter to encourage your feedback in addition to any concerns you may have so they can be heard and addressed. Due to limited common areas that could accommodate a dog park, the proposed location is one of the few areas available where we think the addition of a dog park would be suitable for our community's amenities. The survey below also includes inquiries regarding the potential of constructing a community basketball court. Please see the information and survey below for all details.

## The Site

The proposed location for Travis Ranch Dog Park, if approved, will be at the field between: Rains County Rd., Grimes Dr., and Doole Ct. The proposed site is approximately one acre located at the soccer field. The soccer field would remain, with the dog park being added as a new amenity to the area.

Additional lighting will be added to the site and a comprehensive lighting plan will be completed to evaluate lighting placement. A sidewalk will separate the soccer field from the dog park and provide access to the park. This sidewalk will also provide a walking loop and protect the grass leading to the park. Additionally, we will discuss shielding the lights, so they are more effective, and the light's beams are focused directly on the park instead of nearby homes. Shielding a lamp usually requires using a lower wattage bulb, which in turn, is a big money saver. Shielding also reduces glare that can be dangerous and unsafe, blinding a passerby or creating harsh shadows where "bad guys" can hide. Shielded lighting provides real security and not just the illusion of security, which we want for our families and friends.

Access to the proposed dog park will be through a key card gate and would be restricted to registered dog owners only from within the community. Several parking spots (3-4) will be added to the end of Doole Ct. and the remaining parking will be street side along the adjacent streets. A large portion of the traffic to the park will be pedestrian.

It is suggested that the dog park will be open year-round, though the peak months are expected to be spring, summer, and fall. We suggest the park close between the hours of 10 PM & 6 AM daily. Additional trees and landscaping will also be planted around the fenced area to provide additional shade and to improve the aesthetics of the park.

The HOA is working with the Dog Park committee and the Advisory Committee to put out a survey on the dog park, along with other amenities we would like to add to the neighborhood. To help us make an informed decision, we encourage you to participate in the below survey and provide feedback on the proposal.


